- **Promoting the Healthy:** Conversely, the State must actively encourage the reproduction of the racially pure and physically healthy. This is framed as a necessary investment in the future of the race.

The author views the failure to implement such measures as a form of **slow national suicide**. The State that allows its best blood to be diluted and its weakest elements to multiply is a State that has failed its most sacred duty.
